GENERAL INFORMATION AND TEST RULES

Entry Limits: TDX - there are 6 tracks offered with 1 track being set aside for test workers as set by the AKC tracking regulations. Judges may plot an alternate track to be used according to AKC regulations.

Drawing for Acceptance into test: The drawing will be held at Arby's, 60 Hilltop Village Center Dr. in *Eureka, MO* on November 21, 2023 at 8 p.m. to determine which entrants will participate in the test and the position of excess entrants on the Alternate List. There will be two drawings - first draw will be for past test workers. Preference is given to entrants who have not earned the title of TDX. All entrants will be advised by email, if such address has been provided, on November 22 2023 otherwise you will be notified by USPS mail.

Drawing for running order of tracks:

Draw will be 9:30 am at test headquarters in Sullivan Fairgrounds.

Refunds: Entry fees will be refunded to alternates who decline to be placed on the Alternate List or to alternates who do not participate in the test. Entry fees will NOT be refunded to a scheduled entrant who is absent on the test date unless an alternate is present and runs in the place of the absent dog.

Returned Checks: There will be a \$25.00 charge when a check is returned.

RISK: The owner or agent entering a dog in a Tracking Test does so at his/her own risk and agrees to abide by all of the Rules and Regulations of the American Kennel Club. Gateway assumes no responsibility for any personal injury or death of any person, theft of personal property, theft, injury, or death of any animal or loss of or damage to any property while at this test or on the test site, or in transit to or from the site.

Permission to use properties in and around Sullivan, Missouri is for this Tracking Test only. All dogs must be on lead at all times. We ask that you use the dedicated exercise area when possible and always clean up your dog's waste.
